- c) The RENTER is responsible and required to ensure a **trip inspection report is completed** before departure to their said destination. Failure to do so and resulting in fines being issued by the Ministry of Transportation, Insurance Corporation and/or provincial traffic control detachments, including but not limited to the Royal Canadian Mounted Police, will be the sole expense of the RENTER and will be billed accordingly.

Section 3: AUTHORIZED BUS DRIVERS

The Gitanyow Independent School must approve the driver of the school bus.

If RENTER is providing a driver, the driver must provide copies of the following:

- 1) Valid driver’s licence - minimum Class 2. Attached
- 2) Driver’s abstract (online: www.icbc.com or phone: 1-800-663-3051) Attached

If the OWNER is providing an approved driver, the RENTER will be invoiced \$27.00/hour for the driver (drive time and on-duty time). The OWNER will add an hour for the driver to clean the bus.

Section 4: RENTAL RATES & FUEL CHARGES

The RENTER agrees to pay the OWNER the following:

- **User Fee:** \$50.00/day
- **Per Kilometer:** \$1.50/km
- **Fuel:** The bus is provided fully fueled. Upon return, if the tank is not full, a charge of **\$3.00 per litre** will be applied to the final invoice.

Section 5: CONDITIONS AND RESTRICTIONS

The RENTER agrees (by initialling each section) to abide by all conditions and restrictions outlined in Attachment “A”.

ATTACHMENT "A"

1) **TOBACCO:**

- a. The RENTER understands the rental vehicle is TOBACCO-FREE. Initial:
- b. If any evidence of tobacco being used of any kind is detected, as determined by OWNER, the RENTER agrees to pay an additional CLEAN-UP CHARGE OF \$250.00 for steam cleaning the interior of the bus.

2) **GARBAGE:** The RENTER agrees the bus is to be returned in CLEAN ORDER.

Initial:

- a. Swept and mopped.
- b. Seats to be sanitized.
- c. All garbage and debris are to be removed from the bus.
- d. Any garbage that requires vacuum cleaning is to be completed before returning the bus.
- e. If the bus is not returned in clean order, the RENTER agrees to pay an additional CLEAN-UP CHARGE OF \$250.00.

3) **RESTRICTIONS:** The RENTER agrees the vehicle is to be operated safely and prudently, particularly regarding but not limited to the following conditions:

Initial:

- a. There shall be absolutely no alcohol, drugs smoking or sunflower seeds on the rental bus.
- b. The bus will not be driven by any other person other than the authorized driver noted in Section 3 of this agreement.
- c. The rental bus shall not carry passengers over the designated capacity.
- d. The rental bus shall not be used for any illegal purposes.
- e. The rental bus shall not be for carrying passengers other than in the interior or cab of the bus.
- f. The rental bus shall not be used to carry passengers or property for hire.
- g. The rental bus shall not be used to push, propel or tow another vehicle(s).
- h. Installation of any luggage racks or other items, on the rental bus, is prohibited.
- i. The rental bus is only available for use within BC, unless prior approval has been granted.

4) **SAFETY:** The RENTER agrees the vehicle is to be operated safely and prudently, particularly regarding but not limited to the following conditions:

Initial:

- a. Authorized driver shall not negligently operate the said bus.
- b. Authorized driver will ensure a trip inspection report of the said bus is completed before departure to their destination, including tire inflation pressures will be checked and maintained.
- c. The authorized driver and all passengers will follow the bus safety rules indicated by the RENTER, including but not limited to the following:
 - i. Rules listed according to ICBC.com Driving Commercial Vehicles, Chapter 6: <https://www.icbc.com/driver-licensing/driving-guides/Pages/Driving-commercial-vehicles.aspx>
 - ii. All passengers shall remain in their seats while the vehicle is mobile.
 - iii. All passengers must not extend their arms or heads out the windows

5) INSURANCE & DAMAGE OR LOSS:

Initial:

- a. By signing the RENTER understands the rental bus is fully insured by Gitanyow Independent School.
- b. In the event of damage to the rental bus, due to vehicle accident (collision/comprehensive) or rock chips to windshield, the RENTER is liable for the deductible amount under the Gitanyow Independent School's vehicle insurance policy.

6) LIABILITY:

Initial:

- a. The RENTER agrees that the Gitanyow Independent School is not responsible or liable for any passengers or items during the rental usage of the rental bus.
- b. The RENTER understands they are responsible for all traffic fines, parking fines, and similar costs.
- c. The RENTER agrees the Gitanyow Independent School is not responsible for any expense or liability incurred during my rental period.
